2. The volume / weight ratio for airfreight charges will be calculated at 6:1 and charged based on whichever yields the greater.
3. Destination ocean freight FCL/LCL charges and airport terminal fees will be passed on as per outlay. (Approx. US\$237/40', US\$175/20', US\$18/LCL & US\$0.2/kg)
4. Cargos arrive earlier than specified will be subject to storage fees of HK\$28 cbm/month, minimum 1cbm; however if cargos arrive later than 5 days prior to opening will incurred a 3% surcharge on basic prices.
5. Full container loads will be charged at a minimum of 20 cbm/20' and 40 cbm/40'.
6. Storage of empty cases during the period : US\$ 19/cbm(min. US\$19)
