- The original copy of the acknowledgement letter, passport with landing slip, business card, boarding pass and e-ticket receipt MUST BE presented upon the reimbursement collection. HKTDC reserves the right to reject any reimbursement requests should there be any informational discrepancies on the passport, landing slip, boarding pass and e-ticket receipt.**
